CITY COUNCIL MEETING MINUTES

6:00 PM – May 6, 2019 Cadillac City Hall – 200 N. Lake St. - Cadillac, Michigan 49601

CALL TO ORDER

Mayor Filkins called the City Council meeting to order at approximately 6:00 pm.

PLEDGE OF ALLEGIANCE

APPROVAL OF AGENDA

2019-084 Approve agenda as presented.

Motion was made by Spoelman and supported by King to approve the agenda as presented.

Motion unanimously approved.

PUBLIC COMMENTS

Jamie Stearns commented on the current recycling program.

Randy Lindell commented on the City's shooting range, Cadillac Junction, The Market, traffic in the downtown area, proposed water/sewer rate increases, and damage caused from construction traffic at the former Oleson's site.

CONSENT AGENDA

2019-085 Remove regular meeting minutes from Consent Agenda.

Motion was made by Spoelman and supported by Schippers to remove the minutes from the regular meeting held on April 15, 2019 from the Consent Agenda to have a discussion about them.

Motion unanimously approved.

Spoelman stated that during the budget discussion she had questioned the Fund Balance and whether or not it was restricted vs. unrestricted. She noted the minutes do not reflect that it was the Fund Balance she was asking about. She stated the minutes just refer to the General Fund and there is a difference.

2019-086 Approve regular meeting minutes as amended.

Motion was made by Spoelman and supported by King to adjust the minutes from April 15, 2019 to reflect that the question asked by Spoelman during the budget discussion was related to the Fund Balance.

Motion unanimously approved.

2019-087 Approve closed session minutes as presented.

Motion was made by Schippers and supported by Spoelman to approve the minutes from the closed session held on April 15, 2019 as presented.

Motion unanimously approved.

PROCLAMATION

A. Letter Carriers' Stamp Out Hunger Food Drive Day

Ruth Reddy, representing the Letter Carriers from the Cadillac Post Office, introduced herself and noted they are spearheading the Food Drive.

Mayor Filkins read a Proclamation in honor of "Letter Carriers' Stamp Out Hunger Food Drive Day" to be held on May 11, 2019.

COMMUNICATIONS

A. Groupe Beneteau Annual Dealer Show

Peccia stated Groupe Beneteau will be hosting a Dealer Show from September 22, 2019 through September 27, 2019. He noted they are requesting permission to utilize the public boat dock area adjacent to the Rotary Performing Arts Pavilion.

Christophe Lavigne, President of Rec Boat Holdings which was acquired by Groupe Beneteau, provided a brief description of the company. He stated they are expecting approximately 500 guests to be in attendance and there will be approximately 20-30 boats on Lake Cadillac during the Dealer Show. He noted they will likely need to find additional parking close to the Test Center. He asked if it would be possible to utilize The Market in the event of inclement weather.

Peccia requested the motion include authorization for City staff to work out any logistical issues that may need to be addressed.

2019-088 Approve request from Groupe Beneteau for use of public docking spaces.

Motion was made by King and supported by Schippers to approve the request from Groupe Beneteau allowing them to reserve public spaces during their Annual Dealer Show on Sunday, September 22, 2019 through Friday, September 27, 2019 and authorize City Staff to work on other logistics that may be necessary for the event.

Motion unanimously approved.

Memorial Day 5k event.</u> Motion was made by Spoelman and supported by King to approve the closure of Linden St. between Chestnut St. and W. Division St. from 8:00 am to 8:45 am on May 27, 2019 for the Cadillac Rotary STRIDE for S.T.R.I.V.E. Memorial Day 5k event.

Motion unanimously approved.

Peccia stated it would be appropriate for Council to set a public hearing for May 20, 2019 regarding the Ordinance Establishing the General Appropriations Act for Fiscal Year 2020.

2019-092 Set public hearing for Ordinance 2019-04.

Motion was made by Spoelman and supported by Schippers to adopt the resolution to introduce the Ordinance Establishing General Appropriations Act for Fiscal Year 2020 and set a public hearing for May 20, 2019.

Motion unanimously approved.

B. Adopt resolution to introduce Ordinance Amending Zoning Map and set a public hearing for May 20, 2019.

Peccia stated the next three (3) requests are recommendations that were unanimously moved forward from the Planning Commission.

John Wallace, Community Development Director, noted the Munson Healthcare Cadillac Hospital rezoning request is a continuation of prior action by the Planning Commission and

the City Council. He stated a large section of the block in front of the hospital was rezoned for the McAuley Children's Center and Preschool. He noted during that process it came to their attention there were two (2) lots that were inadvertently omitted from the rezoning application. He stated Munson Healthcare Cadillac Hospital desires to have the two (2) lots included in the same zoning district as the McAuley Center. He stated the hospital owns most of the block with the exception of one (1) lot immediately to the east of that block so they also want to move that rezoning forward at the same time.

Wallace provided a presentation regarding the proposed Ordinance Amending the City Zoning Map and the proposed Ordinance Amending Zoning Ordinance Regarding Accessory Uses. (see attachment)

Engels asked if anyone expressed opposition to the requested rezoning at the Planning Commission meeting.

Wallace stated there were no objections expressed at the last Planning Commission (PC) meeting. He noted at the prior PC meeting an individual expressed opposition to a future playground but they were not objecting to the daycare center.

Wallace noted the Accessory Use Amendment is a Text Amendment to Section 46-657 Accessory Uses. He stated it is an amendment which involves the creation of a Subsection B which addresses accessory use locations.

Peccia stated the daycare facility is located on one parcel and the accessory use, which in this case is a playground, would be located on a separate adjacent and contiguous parcel. He noted without the Accessory Use Amendment the playground would not be permitted.

2019-093 Set public hearing for Ordinance 2019-05.

Motion was made by Engels and supported by Schippers to adopt the resolution to introduce Ordinance Amending Zoning Map (Munson) and set a public hearing for May 20, 2019.

Motion unanimously approved.

C. Adopt resolution to introduce Ordinance Amending Zoning Ordinance Regarding Accessory Uses and set a public hearing for May 20, 2019.

2019-094 Set public hearing for Ordinance 2019-06.

Motion was made by Engels and supported by Spoelman to adopt the resolution to introduce Ordinance Amending Zoning Ordinance Regarding Accessory Uses and set a public hearing for May 20, 2019.

Motion unanimously approved.

D. Adopt resolution to introduce Ordinance Amending Zoning Map and set a public hearing for May 20, 2019.

Wallace provided a presentation regarding the proposed Ordinance Amending the City Zoning Map. (see attachment)

Wallace noted the rezoning request is regarding New Hope Shelter. He stated New Hope Shelter decided to centralize their homeless operations. He noted the Special Land Use was approved by the Planning Commission conditional upon City Council granting the rezoning request. He stated New Hope Shelter is requesting the rezoning of a site on Lincoln Street just east of the Wexford County Jail from R-1 One Family Residential to a RM-2 Multiple Family Residential.

2019-095 Set public hearing for Ordinance 2019-07.

Motion was made by Spoelman and supported by Schippers to adopt the resolution to introduce Ordinance Amending Zoning Map (New Hope Shelter) and set a public hearing for May 20, 2019.

Motion unanimously approved.

ADOPTION OF ORDINANCES AND RESOLUTIONS

A. Adopt resolution to approve the amendment to Consumers Energy Contract and to approve the new Consumers Contract.

Peccia stated the amendment to the contract is regarding the replacement of failed light fixtures with more efficient LED fixtures.

2019-096 Adopt resolution regarding Consumers Energy Contract.

Motion was made by Spoelman and supported by Schippers to adopt the resolution to approve the amendment to Consumers Energy Contract (ending in 5462) and to approve the new Consumers Contract (ending in 7816) noting that street light costs are paid from the Public Works Department in the General Fund.

Motion unanimously approved.

PUBLIC COMMENTS

Randy Lindell commented on the proposed water rate increase, out-of-state travel by the City Manager, use of public parks/docks, Rec Boat Holdings, and New Hope Shelter.

GOOD OF THE ORDER

Peccia noted Parks Clean-Up Day and the collaborative Household Hazardous Waste Day will be held on May 11, 2019.

Peccia stated all of the costs associated with the extension of public utilities to the property commonly known as the TeriDee property (Cadillac Junction) was paid for by the developer. He added once the infrastructure was in place the developer conveyed it to the City at no cost. He noted the City was required to update its pumps and lift station by the MDEQ for the entire eastside sewer infrastructure that serves not only the TeriDee property (Cadillac Junction) but also serves the new jail site and other commercial and residential properties in the area.

Peccia noted he is not the first City Manager to travel out-of-state.

Peccia stated the City of Cadillac does not own or operate automatic weapons but it does have a partnership with other law enforcement agencies with respect to the use of the City's shooting range. He

noted the City's shooting range has been operational since the 1980s and is located in an area that is protected by a large berm.

Spoelman asked if the City has received any other complaints regarding the firing range.

Peccia stated the City has not received any other complaints.

King noted his office is located in an area near the shooting range and he does not find it to be a problem.

Schippers briefly discussed the Earth Day Event that was held on April 28, 2019. She thanked City staff for their assistance. She noted the Mayor's Youth Council volunteered in the children's area.

Schippers stated several more members have been approved to join the Mayor's Youth Council.

Spoelman stated Marty Williams has assembled a group that is hoping to do a clean-up of the entire Clam River within the City limits. He noted Groupe Beneteau has donated to this cause.

Spoelman stated she wanted to comment on some of the concerns expressed by Jamie Stearns. She noted she appreciates that the City is working to address her concerns. She stated she understands that every recycler cannot accept the same materials but it really depends on the aftermarket. She believes they are trying to find aftermarkets that are economically feasible for them. She stated she feels the current recycler is doing a great job. She noted she has not heard any complaints about their service. She noted the City has been able to keep recycling costs manageable and it's unfortunate that more people don't take advantage of the service. She stated she agrees more education for the public would be useful. She noted reducing usage of materials, such as single-use plastics, would be beneficial.

Peccia stated he will be meeting with the service provider in the near future. He noted the service provider has agreed to slightly adjust how they will be collecting the materials. He stated all materials will be collected at the curb and the final sorting will be conducted at the recycling facility.

Peccia stated there is one item to report in regard to the current litigation with the Lake Mitchell Sewer Authority (LMSA).

City Attorney Homier stated we have had an opportunity to discuss a revised contract submitted by the LMSA through Council. He noted the basic framework of the revision is to extend the contract from the existing twenty-one (21) year agreement to a forty (40) year agreement. He stated it also serves the LMSA because they are seeking some financing through USDA Rural Development. He noted the rate structure remains the same it just adjusts it to 40 years instead of 21 years.

Homier recommended the City Council approve the revised contract with the Lake Mitchell Sewer Authority and authorize the City Manager and City Attorney to review and approve any and all changes to the contract provided that such revisions do not affect the material terms of the contract and authorize the City Attorney to dismiss the lawsuit without costs or attorney fees when the contract is executed.

Spoelman asked if the City originally proposed a 40-year contract.

Homier stated the City did originally propose a 40-year contract.

2019-099 Approve revised contract with the LMSA and dismiss the lawsuit. Motion, as stated by the City Attorney, was made by Schippers and supported by King.

Motion unanimously approved.





Land Use:

All of the property which is the subject of the rezoning is owned by Munson Healthcare Cadillac Hospital and is contiguous to the broader hospital campus. The entire campus is being used for hospital, medical services, and accessory support uses.

Zoning:

 This rezoning would place all of the Munson owned property on Blocks 20 and 21 in an OS-2 Zoning District. The entire Munson Healthcare campus would fall within either the OS-1 or OS-2 Zoning Districts.

Zoning

- The OS-2 Zoning District would allow Munson Hospital greater flexibility in their long term master planning for their future campus. This district allows the best flexibility for medical support offices and services and well as potential for residential use.
- Munson Healthcare is one of Cadillac's largest employers and is an economic driver not only for the city but for this area of the city. The OS-2 District is the most appropriate district as the campus continues to grow in both the amount of medical services, but also the range of medical services.


Recommended Motion:

That the Planning Commission recommends to the City Council that this rezoning application which involves two lots from Block 20 (zoned OS-1) and five lots from Block 21 (zoned R-3) be rezoned to the OS-2 Zoning District.

Accessory Use Amendment


Text Amendment to Section 46-657 Accessory Uses. Amendment involves the creation of a Subsection B which addresses accessory use locations.

Amendment Text



B. Accessory Use Locations: In addition to being permitted on the same parcel as a primary use, accessory uses to non-residential uses may be approved on a lot which is separate from the lot on which the primary use is located if such lot is directly contiguous or contiguous a public street right-of-way and within the same zoning district classification. Such accessory uses shall be accessory to a use permitted by right and which is operating from within an enclosed building. Accessory uses not on the same parcel as the primary use they serve shall also required administrative site plan review by the city's department heads and consulting engineer.






The applicant is requesting to rezone a site on Lincoln Street Just east of the Wexford County Jail from a R-1 Residential District to a RM-2 Residential District.

Land Use Analysis

- Area Churches dominate the land use in the area. These churches according to Mark Mogen work with New Hope Shelter and support the project.
- Master plan land use designation for this area are consistent with the proprosed use including the East Divsion Corridor District and the Mixed Use Crosby Road District.
- Planned uses for this area include religious institutions, multiple family residential, senior and assisted living housing, and professional offices.





Land Use/Zoning Analysis

- Master plan land use designation for this area are consistent with the proprosed use including the East Divsion Corridor District and the Mixed Use Crosby Road District.
- Planned uses for this area include religious institutions, multiple family residential, senior and assisted living housing, and professional offices.
- Zoning for this area is predominately R-2 and OS-1. Existing zoning districts are not consistent with the city master plan.

Recommended Motion:

That the Planning Commission recommends to the city council that the rezoning application from New Hope Shelter/Church of the Nazarene to rezone property as legally described in the application from R-1 to RM-2 be approved.

Basis for Recommendation:

The basis for this recommendation is the existing land use pattern and the city's master plan. The area between the site to be rezoned and E. Division Street is dominated by religious institutions, a medical office, and the Wexford County Jail. The master plan designates this area for similar uses and medium density residential including multiple family housing.

The City of Cadillac recently completed all the activities planned at 207 and 215 South Mitchell Street as part of the Cadillac Lofts Demolition and Site Preparation project. The project, supported by a Community Development Block Grant (CDBG), came in under budget at \$749,652, down from an original estimate of \$907,100. The grant funds were used for predemolition services, engineering, demolition, lead and asbestos abatement, and grant administration. Private funds in the amount of \$5,285 were used for clock tower removal. This project qualified for CDBG funds under the national objective of elimination of spot blight.

No local funds were paid by the City of Cadillac for this project.

No people were displaced as a result of this project.

Dean DeKryger, owner of The DK Design Group, served as the prime contractor and is planning to be in attendance to answer any questions specific to the on-site project activities.

Next Steps

- City Clerk must provide a brief description of the public hearing including the date of hearing, number of citizens attending the hearing and a summary description of substantive comments made at the hearing.
- City Staff, with CDBG Administrator assistance, will provide documentation required as part of the monitoring phase to close-out the grant.

Sec. 46-657. - Accessory uses.

- A. Accessory Use Examples: an accessory use includes, but is not limited to the following:
 - (1) Residential accommodations for up to two servants and/or caretakers.
 - (2) Swimming pools for the use of the occupants of a residence, or their guests.
- (3) Domestic or agricultural storage in a barn, shed, tool room, or similar accessory building or other structure.
- (4) A newsstand primarily for the convenience of the occupants of a building, which is located wholly within such building and has no exterior signs or displays.
- (5) Storage of merchandise normally carried in stock in connection with a business or industrial use, unless such storage is excluded in the applicable district regulations.
- (6) Storage of goods used in or produced by industrial uses or related activities, unless such storage is excluded in the applicable district regulations.
- (7) Accessory off-street parking spaces, open or enclosed, subject to the accessory off-street parking regulations for the district in which the zoning lot is located.
- (8) Uses clearly incidental to a main use such as, but not limited to, offices of an industrial or commercial complex located on the site of the commercial or industrial complex.
- (9) Accessory off-street loading, subject to the off-street loading regulations for the district in which the zoning lot is located.

- (10) Accessory signs, subject to the sign regulations for the district in which the zoning lot is located.

Accessory Use Locations: in addition to being permitted on the same parcel as a primary use, accessory uses to non-residential uses may be approved on a lot which is separate from the lot on which the primary use is located if such lot is directly contiguous or contiguous across a public street right-of-way and within the same zoning district classification. Such accessory uses shall be accessory to a use permitted by right and which is operating from within an enclosed building. Accessory uses not on the same parcel as the primary use they serve shall also require administrative site plan review by the city's department heads and consulting engineer.

No free service shall be furnished by the system to the city or to any person, firm or corporation, public or private, or to any public agency or instrumentality.

(1) Metered users.

a. *Base Rate.* The base rate for metered users is as follows:

 - a. All commercial, industrial, and institutional accounts shall have a water meter installed. The meter shall be installed under the direction of the city utilities department. The cost of installation shall be borne by the owner. The cost of replacement shall be borne by the utilities department.

- b. All residential customers shall be given the option of having a water meter installed as provided for above, or the residential customer shall be billed a flat rate sewer charge equal to the average billing as determined on an annual basis.
- c. The average monthly residential sewer bill, as of July 1, 2019, is a charge of \$28.25.
- (5) Watering adjustment basis.
 - a. For all residential users, charges for sewer for the months of May, June, July, August and September shall be computed for each account based on the average metered water consumption for the base period of the preceding October, November, December January and February. If no previous base history is available, a citywide residential average will be used.
 - b. For all other users, a separate meter may be purchased and installed at owner's expense, which will be utilized for watering only with the billing to reflect that amount.

Section 2.

All other ordinances inconsistent with the provisions of this Ordinance are hereby repealed only to the extent necessary to give this Ordinance full force and effect.

Section 6, Millage Levies.

- (a) The City will levy a tax of 13.9166 mills for the period of July 1, 2019 through June 30, 2020, on all real and personal taxable property in the City, according to the valuation of the same. This tax is levied for the purpose of defraying the general expense and liability of the City and is levied pursuant to Section 20.6, Article 20 of the City Charter. The maximum authorized levy according to the City Charter is 15.00 mills.
- (b) The City further levies a tax of 2.60 mills for the period of July 1, 2019 through June 30, 2020, on all real and personal taxable property in the City, according to the valuation of the same. This tax is levied for the purpose of defraying the cost of supporting the retirement plan for personnel of the police and fire departments of the City pursuant to the provisions of Public Act 345 of 1937, as amended, as approved by a vote of the citizens of the City on November 8, 1977.

(c) The City further levies a tax of 1.9548 mills for the period of July 1, 2019 through June 30, 2020, on all real and personal taxable property in the City, according to the valuation of the same in a district known as the Downtown Development District. This tax is levied for the purpose of defraying the cost of the Downtown Development Authority.

Section 7, Adoption of Budget by Reference.

The general fund budget of the City is hereby adopted by reference, with revenues and activity expenditures as indicated in Sections 5 and 6 of this Act.

Section 8, Transfer Within Appropriation Centers.

The City Manager is hereby authorized to make budgetary transfers within the appropriation centers established throughout this budget. All transfers between appropriations may be made only by further resolution of the City Council pursuant to Section 10.5 of the City Charter and Section 19(2) of the provisions of the Michigan Uniform Accounting and Budget Act.

Section 9, Appropriations by Resolution,

The City Council may, by resolution, make additional appropriations during the 2020 Fiscal Year for unanticipated expenditures required of the City, but such expenditures shall not exceed the amount by which actual and anticipated revenues of the fiscal year are exceeding the revenues as estimated in the budget unless the appropriations are necessary to relieve an emergency endangering the public health, peace or safety.

Section 10, Effective Date. This Ordinance shall take effect on July 1, 2019.

Re: Fireworks Ordinance Revision

In 2011, the State of Michigan passed legislation that allowed the sale and use of consumer fireworks titled the Michigan Fireworks Safety Act (PA 256 of 2011). First the first time, fireworks that produced concussive effects and/or aerial devices were readily available for purchase throughout the State. In its original form, PA 256 did not allow any local control over the use of consumer fireworks for communities our size, and the only tools available to local communities were noise ordinances, which are difficult to enforce.

After much discussion and debate, the State amended PA 256 in 2013 to allow local communities to prohibit the use of consumer fireworks, however, local communities could not prohibit the use of consumer fireworks on the day before, day of, and day after a national holiday. In 2013, the City enacted an ordinance that limited consumer fireworks in accordance with PA 256, as amended.

In 2018, the State again amended PA 256. The basic structure of the 2013 amendment has been replaced with a more specific time and date criteria that helps to concentrate the use of consumer fireworks to fewer holidays and to weekends around shorter holidays. Due to the 2018 amendment, the staff has revisited its fireworks ordinance and has modified it to be consistent with the 2018 amendment of PA 256, the Michigan Fireworks Safety Act. For reference, please see the following copy of the updated ordinance for consideration.

AN ORDINANCE AMENDING THE CITY CODE REGARDING FIREWORKS

THE CITY OF CADILLAC ORDAINS:

SECTION 1. AMENDMENT OF CHAPTER 18 ARTICLE III

Chapter 18, Article III of the City's Code shall be amended to read in its entirety, as follows:

ARTICLE III. - FIREWORKS SAFETY ACT

SECTION 11.41 – PURPOSE

The purpose and intent of this Ordinance is to regulate the discharge, ignition and use of certain fireworks within the city boundaries consistent with the Michigan Fireworks Safety Act, Act 256 of 2011, as amended.

SECTION 18-42 – DEFINITIONS

The following words, terms and phrases, when used in this Ordinance, shall have the meaning ascribed to them in this section:

Act means the Michigan Fireworks Safety Act, Public Act 256 of 2011, MCL 28.451 – 28.471, as amended.

Agricultural and wildlife fireworks means firework devices distributed to farmers, ranchers, and growers through a wildlife management program administered by the United States Department of Interior or the Michigan Department of Natural Resources.

APA means American Pyrotechnics Association.

Articles pyrotechnic means pyrotechnic devices for professional use that are similar to consumer fireworks in chemical composition and construction but not intended for consumer use, that meet the weight limits for consumer fireworks but are not labeled as such, and that are

classified as UN0431 or UN0432 under 49 CFR 172.101.

Commercial fireworks includes display fireworks, articles pyrotechnic, special effects and agricultural and wildlife fireworks.

Consumer fireworks are as defined in Section 2(f) of the Michigan Fireworks Safety Act, Act 256 of 2011, as amended, (MCL 28.452(f)) and mean fireworks devices that are designed to produce visible or audible effects by combustion, that are required to comply with the construction, chemical composition, and labeling regulations promulgated by the United States Consumer Product Safety Commission under 16 CFR Parts 1500 and 1507, and that are listed in APA standard 87-1, 3.1.2, 3.1.3, or 3.5. Consumer fireworks do not include low-impact fireworks.

Display fireworks means large fireworks devices that are explosive materials intended for use in fireworks displays and designed to produce visible or audible effects by combustion, deflagration, or detonation, as provided in 27 CFR 555.11, 49 CFR 172, and APA standard 87-1, 4.1.

Firework or fireworks means any composition or device, except for a starting pistol, a flare gun, or a flare, designed for the purpose of producing a visible or audible effect by combustion, deflagration, or detonation. Fireworks consist of consumer fireworks, low-impact fireworks, articles pyrotechnic, display fireworks, and special effects.

Low-impact fireworks means ground and handheld sparkling devices as that phrase is defined under APA standard 87-1, 3.1, 3.1.1.1 to 3.1.1.8, and 3.5.

Minor means an individual who is less than 18 years of age.

National holiday means a national holiday is defined in 5 USC 6103 and includes the following:

- a. New Year's Day (January 1st)
- b. Martin Luther King Jr. Day (third Monday in January)
- c. Washington's Birthday (third Monday in February)
- d. Memorial Day (last Monday in May)
- e. Independence Day (July 4th, and on the date selected by the City of Cadillac to celebrate Independence Day, if different)
- f. Labor Day (first Monday in September)
- g. Columbus Day (second Monday in October)
- h. Veterans Day (November 11th)
- i. Thanksgiving Day (fourth Thursday in November)
- j. Christmas Day (December 25th)

NFPA means National Fire Protection Association.

Novelty fireworks means that term as defined under APA standard 87-1, 3.2, 3.2.1,

3.2.2, 3.2.3, 3.2.4, and 3.2.5 and all of the following:

- a. Toy plastic or paper caps for toy pistols in sheets, strips, rolls, or individual caps containing not more than .25 of a grain of explosive content per cap, in packages labeled to indicate the maximum explosive content per cap.
- b. Toy pistols, toy cannons, toy canes, toy trick noisemakers, and toy guns in which toy caps as described in subparagraph a. are used, that are constructed so that the hand cannot come in contact with the cap when in place for the explosion, and that are not designed to break apart or be separated so as to form a missile by the explosion.
- c. Flitter sparklers in paper tubes not exceeding 1/8 inch in diameter.
- d. Toy snakes not containing mercury, if packed in cardboard boxes with not more than 12 pieces per box for retail sale and if the manufacturer's name and the quantity contained in each box are printed on the box; and toy smoke devices.

Special effects means a combination of chemical elements or chemical compounds designed and intended to produce an audible, visual, mechanical, or thermal effect as an integral part of a motion picture, radio, television, theatrical or opera production or live entertainment.

State fire marshal means the Michigan state fire marshal appointed under section 1b of the Michigan Fire Prevention Code, 1941 PA 207, MCL 29.1b.

SECTION 18-43 – PROHIBITIONS

(1) Fireworks Generally.

- a. Fireworks shall not be ignited, discharged or used by: (a) a minor; (b) a person under the influence of alcohol or controlled substances; or (c) on public property, school property, church property, or property of another person, without that organization's or person's written authorization to do so.
- b. Any unmanned free-floating device (sky lanterns) which requires fire underneath to propel it and is not moored to the ground while aloft, have an uncontrolled and unpredictable flight path and descent are so as to pose a potential fire risk and are therefore prohibited.

(2) Consumer Fireworks.

No person shall ignite, discharge or use consumer fireworks in the City of Cadillac; except on the day preceding, the day of, or the day after a national holiday, and in accordance with the Michigan Fireworks Safety Act, Public Act 256 of 2011, as amended. The ignition, discharge or use of consumer fireworks on these holiday dates is permitted between the hours of 8:00 am and 1:00 am, and only in accordance with the Michigan Fireworks Safety Act, Public Act 256 of 2011, as amended. It is unlawful for any person within the city to ignite discharge, or use consumer fireworks within the city except:

- (a) After 11:00 a.m. on December 31 until 1:00 a.m. on January 1.
- (b) After 11:00 a.m. on the Saturday and Sunday immediately preceding Memorial Day until 11:45 p.m. on each of those days.
- (c) After 11:00 a.m. from June 29 through July 4 and the day that the City observes the Fourth of July until 11:45 p.m. on each of those days.
- (d) After 11:00 a.m. on July 5, if that date is a Friday or Saturday, until 11:45 p.m.
- (e) After 11:00 a.m. on the Saturday and Sunday immediately preceding Labor Day until 11:45 p.m. on each of those days.
- (f) After 11:00 a.m. until 11:45 p.m. on any day that the City Council has approved the use of commercial fireworks within the City.

(3) Commercial Fireworks.

Commercial Fireworks shall not be discharged in the City of Cadillac without a permit as required by this Ordinance.

(4) Low Impact or Novelty Fireworks.

The display of low impact or novelty fireworks are regulated by state law and are not regulated by this Ordinance.

SECTION 18-44 – PERMITS

A permit is required for the discharge of commercial fireworks.

- (1) **Permit Application**. A person seeking a permit to discharge commercial fireworks shall complete an application for a permit, which shall be submitted to the Clerk's Office at least 45 days in advance of the proposed discharge date. The application shall include:
 - a. Proof that the applicant is over 18 years in age;
 - b. A license or permit to operate commercial fireworks from the Federal Bureau of Alcohol, Tobacco, Firearms and Explosives;
 - c. A scale drawing of the site, including but not limited to surrounding buildings, the display site as described by NFPA 1123, the spectator viewing area and the parking areas:
 - d. Proof of insurance as set forth in this section;
 - e. Information as to the competency and qualifications of the fireworks display operators as required by NFPA 1123;
 - f. A completed Application for Fireworks Display Permit from the State of Michigan;

- g. A description of the display, including the type and number of fireworks to be discharged;
- h. Proof to the City Fire Marshal or his designee, that the applicant is knowledgeable of the recommended safety requirements outlined in NFPA 1123;
- i. A nonresident applicant shall appoint in writing a resident member of the bar of this state or a resident agent to be the legal representative upon whom all process in an action or proceeding against the person, firm, or corporation may be served; and
- j. Payment of a fee as set forth in Chapter 48 of the City Code.

(2) Permit Approval Process.

- a. The City Clerk or his designee shall review the application for completeness.
- b. The City Fire Marshal or his designee shall review the application and make a written recommendation to the City Council.
- c. The City Council shall review the application and issue a permit if it finds that the following standards have been satisfied:
 - i. The permit application is complete and conforms to the requirements of this Ordinance.
 - ii. The proposed discharge of fireworks shall not have an adverse effect upon public safety.
 - iii. The time, duration and location of the fireworks will not unreasonably disturb the peace of neighboring property owners.

(3) Requirements of Permit Holders.

- a. A permit holder shall be responsible for the discharge of fireworks which shall conform to the approved permit and this Ordinance.
- b. A permit holder shall be responsible for all shells being fired. In the event one or more shells do not explode, the permit holder shall take appropriate measures to locate and properly dispose of the unexploded shell(s).

(4) Transfers.

Permits cannot be transferred or assigned without prior review and approval of the City.

(5) **Revocation.**

Permits shall be revoked and inventory seized if at any time during the term of the permit the terms and conditions of this Ordinance are violated.

SECTION 18-45 – INSURANCE

To protect the public, the applicant shall provide proof of financial responsibility by insurance to satisfy claims for damages to property or personal injuries arising out of an act or omission on

The General Liability and Automobile liability policies shall be issued by an insurer licensed to do business in the State of Michigan with an A.M. Best rating of "A-" or better. If the applicant utilizes city owned property during the display, the City of Cadillac shall be named as additional insured on the General Liability and Automobile Liability policies, and coverage shall be considered primary over any other insurance held by the City.

SECTION 18-46 PENALTY

A violation of this Ordinance shall be deemed a municipal civil infraction, and the penalties described in Article 1, Section 1-14 of the Cadillac Code of Ordinances shall apply, except that (1) the fine for any violation of this Ordinance that occurs on public property shall be in the amount of \$500.00 for each offense, plus costs, damages, expenses, and any other relief allowed by law and (2) the fine for any violation of section 18-43(2) shall be in the amount of \$1,000, \$500 of which shall be remitted to the City of Cadillac Police Department or other local law enforcement agency enforcing this Ordinance.

SECTION 2. SEVERABILITY

Should any portion of this Ordinance be found invalid for any reason, such holding shall not be construed as affecting the validity or enforceability of the remaining portions of this Ordinance.

AN ORDINANCE AMENDING THE CITY CODE REGARDING FIREWORKS

THE CITY OF CADILLAC ORDAINS:

SECTION 1. AMENDMENT OF CHAPTER 18 ARTICLE III

Chapter 18, Article III of the City's Code shall be amended to read in its entirety, as follows:

ARTICLE III. - FIREWORKS SAFETY ACT

SECTION 11.41 – PURPOSE

The purpose and intent of this Ordinance is to regulate the discharge, ignition and use of certain fireworks within the city boundaries consistent with the Michigan Fireworks Safety Act, Act 256 of 2011, as amended.

SECTION 18-42 – DEFINITIONS

The following words, terms and phrases, when used in this Ordinance, shall have the meaning ascribed to them in this section:

Act means the Michigan Fireworks Safety Act, Public Act 256 of 2011, MCL 28.451 – 28.471, as amended.

Agricultural and wildlife fireworks means firework devices distributed to farmers, ranchers, and growers through a wildlife management program administered by the United States Department of Interior or the Michigan Department of Natural Resources.

APA means American Pyrotechnics Association.

Articles pyrotechnic means pyrotechnic devices for professional use that are similar to consumer fireworks in chemical composition and construction but not intended for consumer use, that meet the weight limits for consumer fireworks but are not labeled as such, and that are classified as UN0431 or UN0432 under 49 CFR 172.101.

Commercial fireworks includes display fireworks, articles pyrotechnic, special effects and agricultural and wildlife fireworks.

Consumer fireworks are as defined in Section 2(f) of the Michigan Fireworks Safety Act, Act 256 of 2011, as amended, (MCL 28.452(f)) and mean fireworks devices that are designed to produce visible or audible effects by combustion, that are required to comply with the construction, chemical composition, and labeling regulations promulgated by the United States Consumer Product Safety Commission under 16 CFR Parts 1500 and 1507, and that are listed in APA standard 87-1, 3.1.2, 3.1.3, or 3.5. Consumer fireworks do not include low-impact fireworks.

Display fireworks means large fireworks devices that are explosive materials intended for use in fireworks displays and designed to produce visible or audible effects by combustion, deflagration, or detonation, as provided in 27 CFR 555.11, 49 CFR 172, and APA standard 87-1, 4.1.

Firework or fireworks means any composition or device, except for a starting pistol, a flare gun, or a flare, designed for the purpose of producing a visible or audible effect by combustion, deflagration, or detonation. Fireworks consist of consumer fireworks, low-impact fireworks, articles pyrotechnic, display fireworks, and special effects.

Low-impact fireworks means ground and handheld sparkling devices as that phrase is defined under APA standard 87-1, 3.1, 3.1.1.1 to 3.1.1.8, and 3.5.

Minor means an individual who is less than 18 years of age.

NFPA means National Fire Protection Association.

Novelty fireworks means that term as defined under APA standard 87-1, 3.2, 3.2.1, 3.2.2, 3.2.3, 3.2.4, and 3.2.5 and all of the following:

- a. Toy plastic or paper caps for toy pistols in sheets, strips, rolls, or individual caps containing not more than .25 of a grain of explosive content per cap, in packages labeled to indicate the maximum explosive content per cap.
- b. Toy pistols, toy cannons, toy canes, toy trick noisemakers, and toy guns in which toy caps as described in subparagraph a. are used, that are constructed so that the hand cannot come in contact with the cap when in place for the explosion, and that are not designed to break apart or be separated so as to form a missile by the explosion.
- c. Flitter sparklers in paper tubes not exceeding 1/8 inch in diameter.
- d. Toy snakes not containing mercury, if packed in cardboard boxes with not more than 12 pieces per box for retail sale and if the manufacturer's name and the quantity contained in each box are printed on the box; and toy smoke devices.

Special effects means a combination of chemical elements or chemical compounds designed and intended to produce an audible, visual, mechanical, or thermal effect as an integral part of a motion picture, radio, television, theatrical or opera production or live entertainment.

State fire marshal means the Michigan state fire marshal appointed under section 1b of the Michigan Fire Prevention Code, 1941 PA 207, MCL 29.1b.

SECTION 18-43 – PROHIBITIONS

(1) Fireworks Generally.

- a. Fireworks shall not be ignited, discharged or used by: (a) a minor; (b) a person under the influence of alcohol or controlled substances; or (c) on public property, school property, church property, or property of another person, without that organization's or person's written authorization to do so.
- b. Any unmanned free-floating device (sky lanterns) which requires fire underneath to propel it and is not moored to the ground while aloft, have an uncontrolled and unpredictable flight path and descent are so as to pose a potential fire risk and are therefore prohibited.

(2) Consumer Fireworks.

It is unlawful for any person within the city to ignite, discharge, or use consumer fireworks within the city except:

- (a) After 11:00 a.m. on December 31 until 1:00 a.m. on January 1.
- (b) After 11:00 a.m. on the Saturday and Sunday immediately preceding Memorial Day until 11:45 p.m. on each of those days.
- (c) After 11:00 a.m. from June 29 through July 4 and the day that the City observes the Fourth of July until 11:45 p.m. on each of those days.
- (d) After 11:00 a.m. on July 5, if that date is a Friday or Saturday, until 11:45 p.m.
- (e) After 11:00 a.m. on the Saturday and Sunday immediately preceding Labor Day until 11:45 p.m. on each of those days.
- (f) After 11:00 a.m. until 11:45 p.m. on any day that the City Council has approved the use of commercial fireworks within the City.

(3) Commercial Fireworks.

Commercial Fireworks shall not be discharged in the City of Cadillac without a permit as required by this Ordinance.

(4) Low Impact or Novelty Fireworks.

The display of low impact or novelty fireworks are regulated by state law and are not regulated by this Ordinance.

SECTION 18-44 – PERMITS

A permit is required for the discharge of commercial fireworks.

- (1) <u>Permit Application</u>. A person seeking a permit to discharge commercial fireworks shall complete an application for a permit, which shall be submitted to the Clerk's Office at least 45 days in advance of the proposed discharge date. The application shall include:
 - a. Proof that the applicant is over 18 years in age;
 - b. A license or permit to operate commercial fireworks from the Federal Bureau of Alcohol, Tobacco, Firearms and Explosives;
 - c. A scale drawing of the site, including but not limited to surrounding buildings, the display site as described by NFPA 1123, the spectator viewing area and the parking areas:
 - d. Proof of insurance as set forth in this section;
 - e. Information as to the competency and qualifications of the fireworks display operators as required by NFPA 1123;
 - f. A completed Application for Fireworks Display Permit from the State of Michigan;
 - g. A description of the display, including the type and number of fireworks to be discharged;
 - h. Proof to the City Fire Marshal or his designee, that the applicant is knowledgeable of the recommended safety requirements outlined in NFPA 1123;
 - i. A nonresident applicant shall appoint in writing a resident member of the bar of this state or a resident agent to be the legal representative upon whom all process in an action or proceeding against the person, firm, or corporation may be served; and
 - j. Payment of a fee as set forth in Chapter 48 of the City Code.

(2) Permit Approval Process.

- a. The City Clerk or his designee shall review the application for completeness.
- b. The City Fire Marshal or his designee shall review the application and make a written recommendation to the City Council.
- c. The City Council shall review the application and issue a permit if it finds that the following standards have been satisfied:
 - i. The permit application is complete and conforms to the requirements of this Ordinance.

- ii. The proposed discharge of fireworks shall not have an adverse effect upon public safety.
- iii. The time, duration and location of the fireworks will not unreasonably disturb the peace of neighboring property owners.

(3) Requirements of Permit Holders.

- a. A permit holder shall be responsible for the discharge of fireworks which shall conform to the approved permit and this Ordinance.
- b. A permit holder shall be responsible for all shells being fired. In the event one or more shells do not explode, the permit holder shall take appropriate measures to locate and properly dispose of the unexploded shell(s).

(4) Transfers.

Permits cannot be transferred or assigned without prior review and approval of the City.

(5) **Revocation.**

Permits shall be revoked and inventory seized if at any time during the term of the permit the terms and conditions of this Ordinance are violated.

SECTION 18-45 – INSURANCE

To protect the public, the applicant shall provide proof of financial responsibility by insurance to satisfy claims for damages to property or personal injuries arising out of an act or omission on the part of the applicant. At a minimum, the applicant shall maintain (a) Worker's Compensation and Employers Liability coverage covering the statutory requirements of the State of Michigan and insuring the applicant with an Employer's Liability limit of at least \$500,000, if applicable, and (b) occurrence based Commercial General Liability coverage covering liability arising out of the operations of the applicant, with limits of at least \$3,000,000 per occurrence and (c) Automobile Liability with a limit of \$1,000,000 per occurrence CSL covering all owned, nonowned, and hired automobiles, and shall comply with all requirements of Michigan No-Fault law. The General Liability and Automobile liability policies shall be issued by an insurer licensed to do business in the State of Michigan with an A.M. Best rating of "A-" or better. WHEREAS, the City of Cadillac ("City") is authorized by statute to control its streets, alleys, and public ways, and thereby has the authority to vacate such streets, alleys, and public ways (MCL 117.4h; *Detroit Edison Co v City of Detroit*, 208 Mich App 26, 33; 527 NW2d 9 (1994)); and

WHEREAS, the Charter of the City provides that the City may, by ordinance and upon the affirmative vote of four or more members of the Council, "vacate, discontinue or abolish any highway, street, lane, alley or other public place, or part" (Charter Sec. 5.6);

WHEREAS, the City wishes to consider adopting an ordinance vacating a portion of 10th Street (between the railroad tracks on the East and 4th Avenue on the West) but reserving to the City a public utility easement under, over and through the vacated portion of 10th Street for the purpose of constructing, installing, operating, maintaining or repairing any and all public utilities, including water, sewer, gas, electric, cable, fiber optic, telecommunications and any similar public utilities, and authorizing the Mayor and/or the City Clerk to execute any and all documents necessary to vacate a portion of 10th Street, to release any unneeded utility easements in or near the vacated portion of 10th Street, to reserve a public utility easement and to execute an easement agreement; and



ORDINANCE VACATING A PORTION OF 10TH STREET AND RESERVING A PUBLIC UTILITY EASEMENT IN FAVOR OF THE CITY OF CADILLAC

Section 1 of the proposed ordinance provides that pursuant to MCL 117.4h, the Charter of the City of Cadillac, and other applicable authority, the City vacates and abandons a portion of 10th Street (between the railroad tracks on the East and 4th Avenue on the West) and that the City reserves to itself a public utility easement for the purpose of constructing, installing, operating, maintaining, replacing and repairing any and all public utilities, including water, sewer, gas, electric, cable, fiber optic, telecommunications and any similar public utilities.

Section 2 of the proposed ordinance authorizes the Mayor and/or the City Clerk to execute any and all documents necessary to vacate a portion of 10th Street, to reserve a public utility easement in favor of the City, to release any unneeded utility easements in or near the vacated portion of 10th Street, and to execute an easement agreement.

Section 3 of the proposed ordinance directs the City Clerk to record a copy of the ordinance with the Wexford County Register of Deeds and to send a copy to the State Treasurer.

Section 4 of the proposed ordinance provides that other ordinances inconsistent with the provisions of the ordinance are repealed but only to the extent necessary to give the ordinance full force and effect.

On behalf of the City of Cadillac, the Historic Districts Commission (HDC) is responsible for superintending the historic integrity of Cadillac's two historic districts, the Courthouse Hill Historic District and the Cobbs and Mitchell Building Historic District. This is primarily accomplished through public education and outreach efforts, along with review and approval of construction projects impacting the exterior of structures within the two districts.

The HDC Rules of Procedure (Section VII) require the Commission to prepare for its regular January meeting an annual report reviewing the prior year's activities and outlining future activities. The report is to be made available to the Cadillac City Council and the general public. This instrument serves as the required annual report for 2018. The first HDC annual report was produced in 2005, making this instrument the fourteenth in a series of such reports.


The Courthouse Hill Historic District - Established 2005

The Courthouse Hill Historic District is located one block east of Cadillac's core downtown. The district is mostly within the boundaries of the original 1871 Plat of the Village of Clam Lake, becoming the City of Cadillac in 1877. The district contains some of Cadillac's oldest, grandest, homes. Seventy percent of the buildings were constructed prior to 1910. Most of the homes are wood-framed, built with locally lumbered timbers. Many homes were built by Cadillac's lumber barons and other businessmen. Some of the homes were moved from Jennings, Michigan to Cadillac in the 1920s. The Courthouse Hill area was the first neighborhood in Cadillac to receive street improvements, sidewalks, sewer lines, fire alarm stations, and street lights. Located within the district are two National Historic Sites (the Wexford County Historical Museum, formerly a Carnegie Library constructed in 1906 and the Frank J. Cobbs House, a Colonial Revival home constructed in 1898), the residence of Cadillac founder George A. Mitchell built in 1874, and the First Presbyterian Church built in 1905. The district boundaries are shown on the following graphic.



Cobbs and Mitchell Building Historic District - Established 2011

The Cobbs and Mitchell Building Historic District is a single-site historic district. The District is located along the south border of the downtown Cadillac, east of Lake Cadillac and southwest of the previously-established Courthouse Hill Historic District. The district is comprised of a single parcel of land approximately 0.83 acres in size upon which the Cobbs and Mitchell Building is located. The building, designed by master architect George DeWitt Mason, was completed in 1907 to serve as the offices of George A. Mitchell and Jonathon W. Cobbs, who operated a prominent lumber processing company in Cadillac. In 1938, the building was sold to the Michigan State Highway Department, which used the space as a district headquarters as the State Highway System expanded into Northern Michigan. The interior of the Cobbs and Mitchell Building reflects its original purpose as the offices of Cadillac's lumber barons. Nine varieties of Michigan woods were used, along with marble fireplaces and heavily embossed wall coverings. No two main rooms in the building are finished alike, a practice intended to showcase the variety of finishes that could be created using woods common to Michigan's forests. At present, the building is privately owned and available for reuse. The district boundaries are shown on the following graphic.



Commission Members

Commission Meetings

Commission meetings are held at 5:00 p.m. at the Cadillac Administrative Offices on the second Monday of each month. All meetings are open to the public. Meetings are also taped for subsequent broadcast on the local public television station.

The Commission officially met four times in 2018. In June, July, August, and October regular meetings were held. Approved meeting minutes can be found on the City of Cadillac website under Documents and Reports.

Staff Representatives

The HDC is assisted by the staff of the city's Community Development Department. Staff is responsible for general clerical activities and day to day administrative responsibilities pursuant to oversight of the districts, the intake and processing of work applications for commission review, processing of work applications associated with general building maintenance and activities not requiring commission review, preparation of historic district newsletters and communications, and related tasks. Construction Activity Applications

The HDC received eight construction activity applications in 2018. This was significant because only one work application was submitted for our historic districts in 2017. The applications that were reviewed by the Commission are listed below. The discussion and approval is documented in the HDC minutes on file at the Cadillac Administrative Offices and on the City Website.

Historic Districts Commission (HDC) 2018 work applications

Cobbs Mitchell Building located at 100 E. Chapin St.

There were two work applications submitted in 2018 for the Cobbs Mitchell Building. The application reviewed in March was to replace the current aluminum framed double hung windows with new vinyl fixed (non-opening) energy efficient windows. This request was denied.

The State of Michigan Historic Survey states the neoclassical office building was built in 1907 and is considered a contributing site to the city's historic past. A contributing site or property is any property, structure, or object that adds to the historical integrity or architectural qualities that make the historic district significant.




The second work application was for the HVAC system at the Cobbs Mitchell Building. It was reviewed by our HDC at its August meeting. The HVAC system had already been installed. This too was denied primarily because the conduit was run up the exterior wall and not on the inside of the building.



311 E. Harris St.

This work application was to add onto the home a four season porch at the rear (north) side of the home. The applicant included photo examples of what the finished porch will closely resemble. They also explained the materials to be used and needed repairs to the home that will be a part of the construction project. The application was reviewed at the June meeting. The State of Michigan Historic Survey describes the home as being built in 1903 in a Queen Anne Architectural style. The home is considered a contributing site to the city's historic past.



455 E. Cass St.

455 E. Cass Street also had two work applications submitted to the HDC in 2018. The first one was reviewed at the July meeting and it was to replace the faded worn asphalt shingles on both the home and accessory structure in the rear of the home with new asphalt shingles. The molding under the soffits was to be preserved and an in-ground pool that had not been used in years was to be broken up and filled in. The State of Michigan Historic Survey describes the home as being built in 1908 in a Prairie School Architectural style. The home is considered a contributing site to the city's historic past.



The second work application submitted for 455 E. Cass Street was reviewed at the October 2018 HDC meeting and it was to replace the wood that covered the opening for a garage door on the accessory structure located in the rear yard and replace it with an aluminum garage door.



401 E. Harris St.

The work application for 401 E. Harris Street was to replace the worn asphalt shingles with a metal roof. The homes current use is as a multi-family rental unit. The State of Michigan Historic Survey describes the home as being built between the years of 1883 to 1886 in the Queen Anne Architectural style. The home is considered a contributing site to the city's historic past. It was discussed that very little of the homes original unique features around the roof and soffits still exist today.



404 E. Cass St.

The work application for 404 E. Cass Street was reviewed at the HDC's October meeting. The owner of this rental home applied to replace the worn asphalt shingles with new asphalt shingles. The owner also wished to remove an attached garage on the west side of the home as there is extensive settling of the footings.



Removing the attached garage was denied. The garage was added onto the home decades ago but the reason for the denial was that there was no plan by the applicant to explain how the west side of the home where the garage attached would be preserved. Permission was granted to fix the footing that has settled.



127 Beech St., the former Carnegie Library & home to the Historical Museum

The work application submitted by the Wexford County Historical Society was reviewed at the August meeting. The plan is to restore a section of the roof using materials which includes slate roof replacement. Additionally crown molding under the soffits is to be removed, repaired, and put back in place. Future plans include replacing gutters and downspouts with new copper gutters and downspouts. The long term plan includes over \$600,000 in repairs and improvements to the building which includes improved accessibility for persons with physical handicaps.



Communications

Website Updates

The Courthouse Hill Historic District page (www.cadillac-mi.net/courthousehill) on the City's website contains the following:

Also of interest are updates to the "History of Cadillac" page on the city's site, including a written history of Cadillac, taken from the Final Report of the Courthouse Hill Historic District Study Committee (2005). That same page also contains side-by-side aerial photographs from 1961 and 2012 covering nearly the entire city. The photographs may be enlarged to compare physical differences between then and now. The page may be accessed by visiting the City's website and navigating to "Living In" then "History of Cadillac."

Other Communication Outlets

In addition to the Historic District page on the city website, the activities of the commission were communicated to the public via the following:


• Facebook – The city maintains a page on the Facebook social networking site. The site currently has over 2,000 followers. The site is regularly used to convey information on public events and activities including those of significance to the Historic District Commission.

Commission Projects and Activities

The project to become a designated Certified Local Government community by the Michigan State Historic Preservation Office and National Park Service is currently on hold

In 2018 Meril Mattson and other members of the Wexford Missaukee Historical Society put together displays in the lobby cabinet at City Hall. They used different topics and we received numerous positive comments from the public about the displays. In the summer of 2018 the group put together a display showing the history of the Cobbs Mitchell Building which also had the first tenant in over 15 years (Prein Newhof Engineering) move into the building. The restoration of Cobbs Mitchell continues.





The HDC also keeps on the forefront the deteriorating condition of brick pavers on South Shelby Street, North Shelby Street, and East Mason Streets. Spot repairs have held up pretty well.

Wexford County Historical Society and Museum (WCHS)

The Wexford County Historical Museum is where the most detailed records for historic homes and buildings in Cadillac are kept.

Public Cooperation and Coordination

Since its inception the HDC has attempted to proactively work with the public and district property owners to help ensure that the district's permitting and design requirements do not impose burdensome development costs, result in construction delays, or impose undo hardships. For the benefit of residents and others contemplating work on structures within the district, work applications are accepted up to seven days prior to a scheduled meeting. At this time there are no application review fees.
