CITY COUNCIL MEETING MINUTES

December 18, 2023

Cadillac City Hall - 200 N. Lake St. - Cadillac, Michigan 49601

CALL TO ORDER

Mayor Filkins called the City Council meeting to order at approximately 6:00 pm.

PLEDGE OF ALLEGIANCE

ROLL CALL

Council Present: Elenbaas, Schippers, Engels, Mayor Filkins

Council Absent: King

Staff Present: Peccia, Wallace, Dietlin, Homier (via Zoom), Lanning

APPROVAL OF AGENDA

2023-205 Approve agenda as presented.

Motion was made by Elenbaas and supported by Engels to approve the agenda as presented.

Motion unanimously approved.

PUBLIC COMMENTS

There were no public comments.

CONSENT AGENDA

2023-206 Approve consent agenda as presented.

Motion was made by Schippers and supported by Elenbaas to approve the consent agenda as presented.

Motion unanimously approved.

PUBLIC HEARINGS

A. Public hearing to consider adoption of Ordinance to Amend City Zoning Ordinance to Codify Interpretation of Short-Term Rental Locations.

Peccia noted City Council directed City staff to codify the memorandum from the Community Development Director regarding interpretation of short-term rental locations. He stated the Planning Commission voted unanimously to recommend the proposed amendments to City Council.

Mayor Filkins opened the public hearing.

Andy VanAlst recommended placing a moratorium on adding short-term rentals outside of the districts they are currently allowed in.

John Saari stated the City needs housing and should encourage all types of housing throughout the City.

Mayor Filkins closed the public hearing.

Engels stated this will bring a lot of clarity as we move forward with the rezoning process. He noted that when a single-family residence becomes a home that is not for a family you are removing a house from the housing stock.

Elenbaas asked about short-term rentals being permitted in the B-2 districts by special use permit.

John Wallace, Community Development Director, stated we were asked to develop something that reflected the memo and that is how the interpretation was made from the existing zoning ordinance. He noted that nothing was changed during the codification process.

Elenbaas stated he sees a potential problem with short-term rentals being allowed by special use permit because if one owner receives a special use permit and the owner of a house near it does not then there could be a problem.

Engels stated this makes the B-2 district more restrictive because short-term rentals would be allowed "by right" in the other three (3) districts.

Mayor Filkins stated what we are being asked to approve tonight is what the Planning Commission voted to send forward and this is what we requested.

Peccia stated these are zones that are primarily commercial/recreational. He noted the special use permit component makes it more restrictive for the B-2 district than it is for the other districts (TS-1, TS-2, and B-1).

Schippers noted the B-2 district is adjacent to the business district and possibly adjacent to residential districts. She stated by putting that other safeguard in place we can ensure that people don't take all of the houses just behind the downtown area.

Elenbaas asked who decides to approve or not approve a special use permit.

Peccia stated it is the Planning Commission.

Engels asked if Council is going to continue the discussion of enforcement. He stated it appears that there are new listings on the Airbnb and VRBO websites.

Peccia noted he is not aware of receiving any new complaints since lawsuits were filed against the two (2) property owners that were causing the issues. He stated if there are still people violating the ordinance, nobody has contacted us directly and filed a complaint. He noted if complaints come in, we will go through the process that we did previously.

Schippers asked if we have rules and regulations in place for short-term rentals.

Peccia stated that we do not. He noted this just sets up the legal enforcement of where this use is allowed. He noted we will be looking at establishing a whole robust program.

Elenbaas asked for an update regarding the letters that were sent to the two (2) property owners.

Mike Homier, City Attorney, stated one of cases was dismissed. He noted the property sold after the lawsuit was filed. He stated we sent a follow-up letter to the new owner advising them that the case was in litigation prior to them buying the property and that it may not be used for a short-term rental. He noted the other case is still pending and it's in the discovery phase. He stated he believes that case will be resolved shortly after the new year. He noted it is his understanding that the property may also be listed for sale.

2023-207 Adopt Ordinance 2023-08.

Motion was made by Schippers and supported by Elenbaas to approve the resolution to adopt an Ordinance to Amend Chapter 46 of the City of Cadillac Zoning Ordinance to Codify Interpretation of Short-Term Rental Locations.

Motion unanimously approved.

B. Public hearing to consider Amendment to the Development and Tax Increment Financing Plan for the Harry Vanderjagt Industrial Park.

Peccia noted the Local Finance Development Authority is recommending that Council extend the Tax Increment Financing (TIF) Plan for another three (3) years hoping that we acquire more finite information. He stated the purpose of this is treating the groundwater.

Mayor Filkins opened the public hearing.

There were no public comments.

Mayor Filkins closed the public hearing.

2023-208 Approve Amendment to the Development and TIF Plan for the Harry Vanderjagt Industrial Park.

Motion was made by Engels and supported by Schippers to approve the Resolution to Amend the Development and Tax Increment Financing Plan for the Harry Vanderjagt Industrial Park.

Motion unanimously approved.

She noted we are hoping to swear in some new members at that meeting and then go to Walmart to do bellringing for the Salvation Army. She noted Lt. Greg Bock is camped in the Red Kettle raising money for the Salvation Army. She stated homelessness is a big issue for many people and the Salvation Army and other organizations help these people. She encouraged everyone to donate and/or be a bellringer.

Elenbaas stated he met with a concerned citizen and Adam Ottjepka, Director of Public Safety, regarding the noise ordinance. He noted the citizen had a complaint about the music at Willow that has been going on for months. He noted the noise ordinance covers 11:00 pm to 7:00 am so the Willow is not violating the ordinance. He stated he would like to have Council consider changing the noise ordinance from 11:00 pm to 10:00 pm in the future. He wished everyone Happy Holidays, Merry Christmas, and Happy Hanukkah.

Mayor Filkins expressed her thanks to everyone for having their voices heard by being willing to step forward and participate in the discussion. Re: Friends of the Library

Introduction

The Friends of the Library are asking to place yard type signs in the City Right-Of-Way for the days that they have scheduled to have their Used Book sales in 2023. The next one is scheduled for April 24 through April 27, 2024 (see attached). These three-day events benefit the library and reading programs the Friends of the Library sponsor. Included in the Friends of the Library temporary Sign Permit application is additional information describing their request. Staff have told representatives for the Friends of the Library that council approval is not needed for signs placed on library property if the signs meet the dimensional standards in the ordinance.

The locations the group is requesting are;

- 1. Placement on the Cadillac Wexford Public Library (CWPL) lawn near the comer of Lake Street and the library monument sign.
- 2. Placement near the city parking lot, which is by the CWPL parking lot (on the parking lot side of the sidewalk).
- 3. Placement for two signs that will be located on the street side of the sidewalk in front of the CWPL. These signs will not be near the driveway where they could obstruct the view of drivers entering or leaving the library.
- 4. One yellow sandwich board sign placed on the lawn of Horizon Bank on South Mitchell Street (on the bank side of the sidewalk).

The signs will read as shown in the attached pages with their sign permit application. The locations are where council has approved in previous years.

Requested Council Action

Consider granting permission for the Friends of the Library to place temporary signs at the locations listed above during the hours of the sale on the dates shown in the schedule provided. Additionally allow administrative staff the flexibility to approve changes in dates for Friends of the Library book sales if requested.





<u>Additional Work Space</u>: In addition to the Easement rights granted herein, Owner further grants to Consumers, during initial construction and installation only, the right to temporarily use such additional work space reasonably required to construct said lines. Said temporary work space shall abut the Easement Area, on either side, as required by construction.

<u>Access</u>: Consumers shall have the right to unimpaired access to said line or lines, and the right of ingress and egress on, over, and through Owner's Land for any and all purposes necessary, convenient, or incidental to the exercise by Consumers of the rights granted hereunder.

<u>Trees and Other Vegetation</u>: Owner shall not plant any trees within the Easement Area. Consumers shall have the right from time to time hereafter to enter Owner's Land to trim, cut down, and otherwise remove and control any trees, brush, roots, and other vegetation within the Easement Area. Consumers shall have the right from time to time hereafter to enter Owner's Land to trim, cut down, and otherwise remove and control any trees, brush, or other vegetation located outside of the Easement Area which are of such a height or are of such a species whose mature height that in falling directly to the ground could come into contact with or land directly above Consumers' facilities.

<u>Buildings/Structures</u>: Owner agrees not to build, create, construct, or permit to be built, created, or constructed, any obstruction, building, septic system, drain field, fuel tank, pond, swimming pool, lake, pit, well, foundation, engineering works, installation or any other type of structure over, under, or on said Easement Area, whether temporary or permanent, natural or man-made, without a prior written agreement executed by Consumers' Real Estate Department expressly allowing the aforementioned.

<u>Ground Elevation</u>: Owner shall not materially alter the ground elevation within the Easement Area without a prior written agreement executed by Consumers Real Estate Department allowing said alteration.

<u>Exercise of Easement</u>: Consumers' nonuse or limited use of this Easement shall not preclude Consumers' later use of this Easement to its full extent.

Ownership: Owner covenants with Consumers that they are the lawful fee simple owner of the aforesaid lands, and that they have the right and authority to make this grant, and that they will forever warrant and defend the title thereto against all claims whatsoever.

<u>Successors</u>: This Easement shall bind and benefit Owner's and Consumers' respective heirs, successors, lessees, licensees, and assigns.

<u>Counterparts</u>: This Easement may be executed simultaneously in two or more counterparts, each of which shall be deemed an original and all of which together shall constitute one and the same instrument. It is not necessary that all parties execute any single counterpart if each party executes at least one counterpart.
