King mentioned Burke's family organization and expressed sadness to see it leave but excited to see a new family organization taking its place. King also noted the need for recruitment of businesses into the downtown area.

Engels inquired if the enforcement presentation was given to any other boards. Engels thought the The Historic District Commission, Planning Commission and Zoning Board of Appeals had some of the same concerns and would benefit from the same presentation.

Mayor Filkins stated that there are 215 Model-T automobiles in the area. They are from 26 States and 2 Providences of Canada. They could not say enough about our Community and Cadillac Visitors Bureau and all the help that has been provided to them during their international tour.

They set a record for the biggest event covering as much geographical location from participants at our Market Place.

Peccia echoed the redevelopment ideas of that council previously mentioned.




